#### **POLL RESULTS OF THE AGM**

Reference is made to the notice of annual general meeting of Hope Life International Holdings Limited (the “**Company**”) dated 28 April 2023 (the “**AGM Notice**”) and the circular of the Company dated 28 April 2023 (the “**Circular**”) in relation to the Company’s annual general meeting held on 31 May 2023 (the “**AGM**”). Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

At the AGM, the voting of all resolutions (the “**Resolutions**”) as set out in the AGM Notice had been taken by poll. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed and acted as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of the AGM, the total number of issued shares in the Company was 1,296,000,000 shares, representing the total number of shares in the Company entitling the Shareholders to attend and vote for or against the Resolutions at the AGM. There were no restrictions on any Shareholders casting votes in any of the Resolutions at the AGM and there were no Shares entitling any Shareholders to attend and vote only against any of the Resolutions at the AGM.

No person has indicated in the Circular that he/she/it intends to abstain from voting on or vote against any of the Resolutions at the AGM. No Shareholder was required to abstain from voting in the respect of any of the Resolutions proposed for approval at the AGM.

Shareholders representing 314,258,054 Shares were present, in person or by proxy or corporate representative, at the AGM. The Board is pleased to announce that all of the Resolutions were duly passed by the Shareholders by poll at the AGM.
